Remarks

General:

- For the purpose of this form "ICF users" are students and employees who work in the IMSEAM Core facility.
- ICF users have to be members of Heidelberg University and therefore have to have an Uni ID or a project account. In case this form is filled out prior to the submission of the ID, the latter has to be submitted to the ICF administration as soon as it is available.
- Changes, extensions or termination of being a ICF user have to be announced by the user and the group leader. To end the work at the ICF (and the status as ICF user) use the logout form available on the web page.

Details:

- **Uni ID:** This is the login ID given by the IT department (Rechenzentrum) The Uni ID is sometimes referred to as URZ account. It consists of two letters and three numbers. It is *not* the student register number (Matrikelnummer). In case you have no Uni-ID for some reason (e.g. guest), get a project account from your host insitute.
- **Official e-mail address:** An "official" address contains the domain uni-heidelberg.de or the domian of your home institution. For details see the the university terms of use for e-mail³ ("E-Mail-Nutzungsordnung"). With this e-mail address you will be subscribed to the mailing list "IMSEAM-USERS".
- **Mailing Lists:** As a ICF user, you will be included in the IMSEAM mailing list for announcements and discussions about the institute (general topics).
